17. 19-Oct-2016 ORDERED: consolidating Case No. 1 CA-CV 16-0098 FC and Case No. 1 CA-CV 16-0185 FC. Case No. 1 CA-CV 16-0098 FC is designated the primary number, and the above caption shall be used on all future documents filed in this consolidated appeal. FURTHER ORDERED: suspending these consolidated appeals; vacating the conference of 1 CA-CV 16-0098 scheduled for 10/26/2016, and the conference of 1 CA-CV 16-0185 scheduled for 11/16/2016; revesting jurisdiction in the superior court to allow it to conduct further proceedings to determine whether appellant was deprived of his file and, if so, whether and how that deprivation prejudiced him at trial. FURTHER ORDERED: copy of order from superior court due within 5 days after entry of the order.
