12. 18-Nov-2016 ORDERED: Suspending this appeal to and including 12/8/16, and authorizing and directing the juvenile court to consider the question of its jurisdiction in the termination action and to sign and file an appropriate minute entry or formal order setting forth its findings on that question. FURTHER ORDERED: the juvenile court shall cause a certified copy of it's written, signed order to be transmitted to this court within five days after it's entry, for receipt in any event no later than 12/8/16. FURTHER ORDERED: this appeal shall be automatically reinstated before this court on 12/9/16, without further order, and that if the juvenile court's written, signed order has not been filed before reinstatement, and is sufficient to vest jurisdiction in this court, the appeal shall proceed.
