5. 8-Apr-2024 ORDERED: Motion: Letter (Motion to Reinstate Appeal) (Appellant Pro Per) = GRANTED and reinstating this appeal. A review of the record further shows appellant was represented by appointed counsel at trial, which necessarily required a determination that appellant is indigent. Indigent defendants have a right to appointed counsel on appeal and a right to a copy of the record on appeal at public expense. State v. Stolze, 112 Ariz. 124, 125 (1975). FURTHER ORDERED: Appointing the Maricopa County Public Defender as counsel for appellant.
