FURTHER ORDERED: That no later than 10/13/2023, all parties shall file simultaneous supplemental briefs of 2,000 words or less. The supplemental briefs need not include a statement of facts, and the parties may reference relevant facts by referring to their previously submitted briefs. See ARCAP 3(a). FURTHER ORDERED: Inviting interested parties or organizations to file amicus briefs setting forth their respective positions on the 3 issues presented. Any such amicus brief must be filed no later than 10/27/2023, and shall be limited to no more than 2,000 words. The amicus brief need only include an "argument" and a "conclusion" and may omit the other parts listed in ARCAP 13(a). The court encourages the Attorney General of the State of Arizona and the Maricopa County Public Defender's Office to file amicus briefs. Also, the court's invitation for amicus briefing extends, but is not limited, to the Arizona Attorneys for Criminal Justice, the Arizona Prosecuting Attorneys' Advisory Council, the American Civil Liberties Union of Arizona, the Goldwater Institute, the American Center for Law and Justice, the Becket Fund for Religious Liberty, and the First Liberty Institute. FURTHER ORDERED: Any parties' response to an amicus brief shall be filed no later than 11/08/2023, and shall be limited to no more than 1,000 words. FURTHER ORDERED: That motions for extension of time will not be entertained. FURTHER ORDERED: That the Clerk of the Court is directed to endorse a copy of this order on all parties in the superior court proceedings and the interested parties/organizations listed above, including the Attorney General of the State of Arizona and the Maricopa County Public Defender's Office. FURTHER ORDERED: That upon submission of the briefs ordered above, this court shall re-conference the case. As indicated in a separate order, oral argument will be held on Tuesday, 11/28/2023.
