7.        3-Oct-2023    On September 13, 2023, Appellant Jeffrey Alvarez filed a Petition for Review requesting that this Court grant review and reverse the court of appeals' July 13, 2023, memorandum decision. The Appellee State of Arizona, citing Ariz. R. Crim P. 31.21(f)(1), filed a Notice of Acknowledgment.
- Subsequently, on September 28, 2023, and prior to the Court acting on Appellant's petition for review, Appellant filed a Supplement to Petition for Review, stating that it was filed "in light of this Court's [] opinion" in State ex rel. Mitchel v. Hon. Cooper (Bassett), No. CR-22-0227-PR, 2023 WL 6053536 (September 18, 2023). Appellant did not file a procedural motion requesting the Court's permission to file the Supplement to Petition for Review.
- Additionally, there is no provision in Ariz. R. Crim. P. 31.21 that allows a party to file a supplement to a petition for review; particularly, without seeking permission from the Court in advance.
- Therefore, on the Court's own motion,
- IT IS ORDERED striking Appellant's Supplement to Petition for Review from the record without prejudice to Appellant filing an amended petition for review on or before October 17, 2023, prior to 3:00 p.m. This deadline will not be extended absent extraordinary circumstances.
- IT IS FURTHER ORDERED that any amended petition will replace Appellant's September 13, 2023 Petition for Review and shall comply with the requirements of Ariz. R. Crim. P. 31.21(d), (e), (g), and (h) that outline the requirements for the contents, appendix, form and length, and service of a petition for review. No procedural motions to extend or expand the requirements of Rule 31.21 will be granted absent extraordinary circumstances.
- IT IS FURTHER ORDERED that if Appellant does not file an amended petition by the above deadline, the Court will consider Appellant's September 13, 2023 Petition for Review in due course.
- IT IS FURTHER ORDERED that in the event Appellant files an amended petition, the State may file a response to the amended petition pursuant to Ariz. R. Crim. P. 31.21(f), (g), and (h). (Hon. Clint Bolick)
