3. 24-Apr-2024 Plaintiff/Appellant Mireya Arroyo filed a Notice of Appeal in this expedited election matter on April 23, 2024, pursuant to Rule 10(g), Arizona Rules of Civil Appellate Procedure.
- In lieu of a telephonic scheduling conference, Court staff has consulted with Appellant, Real Party in Interest/Appellee Deborah Ann Begay, and representatives from Maricopa County.
- Maricopa County has advised that it has a deadline of May 13, 2024 to proof and approve the Maricopa County ballots before the ballot printing deadline. Maricopa County shall file this information with the Court forthwith.
- Maricopa County currently does not anticipate that it will be filing a brief in this appeal.
- IT IS ORDERED if either party wishes to use transcripts, such party shall file authorized transcripts as soon as possible. If no authorized transcript can be prepared and filed timely, the parties are encouraged to stipulate to the pertinent facts or testimony or provide pertinent segments of unauthorized transcripts along with their opening and answering briefs.
- IT IS FURTHER ORDERED Appellant shall file the opening brief no later than 4:00 p.m. on Monday, April 29, 2024. The opening brief shall be no more than 3500 words.
- IT IS FURTHER ORDERED Appellee may file an answering brief no later than 9:00 a.m. on Monday, May 6, 2024. The answering brief shall be no more than 3500 words.
- IT IS FURTHER ORDERED Appellant may file a reply brief no later than 4:00 p.m. on Tuesday, May 7, 2024. The reply brief shall be no more than 1500 words.
- IT IS FURTHER ORDERED Maricopa County may file a brief either when the answering brief is due (to address the opening brief) or a response when the reply brief is due (to address the answering brief) and these briefs shall be no more than 3500 words.
- IT IS FURTHER ORDERED that briefs will be in a legible 14-point font, double-spaced, and will include all arguments the parties wish to present to the Court. They may be filed in memorandum format (no tables of contents or authorities).
- IT IS FURTHER ORDERED that copies of all filings must be delivered as required under Rule 10(h).
- IT IS FURTHER ORDERED that in addition to filing briefs with the Clerk of the Supreme Court (with filing and service through AZTurboCourt) all filings are also to be sent by email to all the parties and court staff and to SACrtdocs@courts.az.gov when filed.
