The Court having reviewed the following furlough terms and conditions and hearing the parties stipulate to such, hereby confirms and/or implements the following terms and conditions regarding the furlough of the juvenile:

1. You shall obey all laws and notify your probation officer, within 24 hours, of any contact with any law enforcement officer.
2. You shall report to and carry out all legal requests of your probation officer.
3. You shall not use, possess or consume alcohol, marijuana, dangerous drugs or narcotics.
4. You shall submit to a urinalysis test, blood test or Breathalyzer test at any time at the direction of your probation officer.
5. You shall attend all counseling or other mental health services recommended by the probation department and shall take all prescribed medications.
6. You shall participate in medical, mental, vocational, educational treatment, counseling or training programs as directed by your probation officer.

- 1       **7. You shall not knowingly associate with any person who has a criminal**  
2           **record, is on probation or on parole without written permission from the**  
3           **Court.**
- 4       **8. You shall not knowingly be present where any illegal activities are**  
5           **occurring.**
- 6       **9. You shall not possess or control any firearms, large knives or dangerous**  
7           **weapons of any kind at anytime and such items shall not be kept in your**  
8           **residence.**
- 9       **10. You shall submit to a search and seizure of your person or property at any**  
10           **time by a probation or law enforcement officer at his/her discretion with**  
11           **or without a warrant, with or without probable cause.**
- 12       **11. You shall not leave Navajo or Apache County without the written**  
13           **permission of your probation officer.**
- 14       **12. You shall not watch cable television.**
- 15       **13. You shall play only video games approved by the probation department.**
- 16       **14. You shall watch only "G" or "PG" rated VHS or DVD movies.**
- 17       **15. You shall have no contact with the victims, their immediate or extended**  
18           **family, unless such person files a written request with the Court and the**  
19           **judge issues an order in writing granting such request. This does not**  
20           **include probation staff, court personal, law enforcement officers or**  
21           **persons necessary to carry out the terms and conditions of this furlough.**
- 22       **16. You shall not be allowed to enroll in any public, private or charter school**  
23           **(or any school that is not a secured facility), attend any formal public**  
24           **events (fairs, parades, celebrations, etc.), until you are determined to not**  
25           **pose a threat to yourself or the public and such determination is submitted**  
26           **to the Court in writing by your evaluating psychiatrist and the State and**  
27           **to the Court in writing by your evaluating psychiatrist and the State and**

1 defense and victims are given an opportunity to object at a hearing before  
2 this Court.

3 17. You shall attend school at the detention facility at the direction of the  
4 Court, obey all rules and complete all assignments.

5 18. You shall remain on house arrest and only leave your residence while in  
6 the custody of your parent/guardian, paternal grandmother, probation  
7 staff, or other probation-approved adult.


8 19. Your parent/guardian shall advise your probation officer in writing of any  
9 change in residence at least two (2) weeks prior to any move or as soon as  
10 possible if two (2) weeks is not practicable. The written notice must  
11 include the new address and contact phone number. The State or victims  
12 have the right to object to such a move before this Court.

13 20. Any deletion or addition of a term or condition of this furlough must be  
14 submitted in writing to the Court.
