ORDER TO SHOW
CAUSE

The State of Arizona having filed a Petition in this matter pursuant to A.R.S. § 8-308 and Rules 26(C) and 32(B) of the Rules of Procedure of Juvenile Court, and good cause therefore appearing, the Court hereby orders the parent of the above-named juvenile, Erin Bloomfield, to appear before the Court on April 7, 2011 at 10:00 a.m., to show cause, if any there be, why:

- THE JUVENILE'S PARENT HAS FAILED AND REFUSED TO PAY OUTSTANDING MONTHLY PROBATION FEES IN THE AMOUNT TOTALLYING \$750.00 AND A VICTIM RIGHTS FEE IN THE AMOUNT OF \$25.00 AND A PROBATION SURCHARGE OF \$10.00
- THE JUVENILE'S PARENT(S)/LEGAL GUARDIAN HAS FAILED TO CONTRIBUTE TO THE COST OF CARE OF THE JUVENILE.
- THE JUVENILE'S PARENTS HAVE FAILED TO PAY THE COST OF COUNSELING, TREATMENT, OR AN EDUCATION PROGRAM.
- THE JUVENILE'S PARENTS HAVE FAILED TO MAKE SUFFICIENT EFFORTS TO INSURE THE JUVENILE'S COMPLIANCE WITH THE PROBATION ORDER ENTERED IN THIS MATTER.

IF YOU FAIL TO APPEAR FOR THE HEARING IN THIS MATTER, THE COURT MAY ISSUE A WARRANT FOR YOUR ARREST.

In the event you fail to pay the above-identified amount, any of the following actions will considered:

- a.) The account may be turned over to a collection agency;
- b.) A wage assignment may be issued on all income;
- c.) A Civil Judgment may be recorded at the County Recorder's Office, which would affect your credit standing;
- d.) The amount may be reported to the Tax Intercept Program;
- e.) You may be found in Contempt of Court, the penalty for which could include incarceration.

IF FEES ARE PAID IN FULL BEFORE THE HEARING DATE, THIS HEARING WILL BE VACATED.
