12 THE STATE OF ARIZONA, through its undersigned County Attorney, Michael B.
13 Whiting, Ron Wood the juvenile's Defense attorney, Marsh Gregory the juvenile's Guardian
14 Ad Litem, and Steve Williams the juvenile's mother's attorney, hereby file this Stipulated
15 Disposition Request. Specifically, the undersigned parties request the juvenile be ordered to
16 enter the Devereux treatment facility located in Maricopa County, Arizona, after an
17 acceptance evaluation is conducted by Devereux.

18 If after performing an acceptance evaluation Devereux does not accept the juvenile, the
19 parties request the Court order the juvenile be placed in the care and custody of Youth
20 Development Inc. ("YDI"), located in Phoenix, AZ. Michael Whiting spoke to the Founder
21 and Director of YDI and YDI is willing to accept the juvenile into their facility.

22 Finally, the parties request the Court order the juvenile's treatment records, notes and any
23 other information keep by the juvenile's counselor, Ms. Betty Beaumont, be sent to Devereux
24 to be used during the acceptance evaluation and for treatment in the future should the
25 juvenile be accepted by Devereux. If Devereux does not accept the juvenile into its facility
26 the parties request these treatment notes and other above-mentioned documents be disclosed
27 to YDI for future mental health treatment. The parties ask that the treatment records not be

1 made available to any other person or entity, except those treatment professional at these two
2 facilities, and that such records be sealed as to all other parties.
