The application of C. I. Jackson for appointment of water commissioner for the Woods or Verde Ditch in Yavapai County, Arizona, having been presented to the court and the court having accepted the resignation of Jess Reeves, and it appearing to the court that the administration of the affairs of the Woods or Verde Ditch and the enforcement of the provisions of the judgment and decree entered herein on March 23, 1909, require that a commissioner be appointed to fill the vacancy left by the resignation of Jess Reeves, to join with the remaining commissioners appointed by this court in the administration of the affairs of said ditch and the enforcement of the provisions of said decree,

NOW, THEREFORE, IT IS ORDERED, that C. I. Jackson be, and he is hereby, appointed water commissioner under the decree entered herein on March 23, 1909, to fill the vacancy created by the resignation of Jess Reeves, and he is hereby authorized and empowered to enforce the provisions of said judgment and decree with reference to the payment of assessments for the maintenance and upkeep of said ditch, headgate and appurtenances, and,

IT IS FURTHER ORDERED, ADJUDGED AND DECREED, that the commissioners, to-wit, Marion E. Davidson, H. C. Gambe and C. I. Jackson, be, and they are hereby, authorized and empowered to

1 carry out the terms and conditions of said judgment and decree
2 with reference to the appropriate uses of the waters of said
3 Woods or Verde Ditch and all other matters relating to the main-
4 tenance of said ditch and appurtenances and the use of the
5 waters therein.
