

ATTACHMENT

This property is surrounded by a steel fence with a locked gate. Part of the fence is electrified. A travel trailer and a garage/shop are about 150 yards from the fence. A sign was posted that said "guard dogs" very aggressive dogs were inside the perimeter of the fence. We tried honking and the dogs were barking but no one would come out. A white pickup truck was parked there. An alternate means of service would be necessary to serve these documents, such a posting on a stake in front of the fence and mailing to the defendant.
