The preliminary plans as reflected in Exhibits 1, 2 and 3 are deemed acceptable to the Master of the Verde Ditch subject to the conditions stated in the Commissioners' Petition which are incorporated herein by reference.

3. The Verde Ditch Commissioners are authorized to review and approve any final plans submitted by the Camp Verde Sanitary District, consistent with the limitations set forth in the Petition submitted by the Commissioners.
