27 Defendants, by and through undersigned counsel, do hereby move the Court for an expedited  
28 Order allowing an exhibit to be removed from the Court file for copying. Attached to Defendants'  
29 Response to Plaintiffs' Request for the Court's On-Site Inspection of Subject Real Property  
30 Subdivision filed on August 11, 2004, is a large parcel map. Undersigned's copy of that map was  
31 inadvertently destroyed during the move to undersigned's new law office. To avoid having to make


