ORDER TO SHOW CAUSE

Upon reading the verified petition of C. I. Jackson and Marion Davidson, duly appointed and qualified Commissioners of the Lower Verde Ditch and Upper Verde Ditch, and for good cause appearing therefrom:

IT IS HEREBY ORDERED that EVELYN JOHNSON appear and show cause, if any she has, in the Courtroom of the Superior Court of Yavapai County Courthouse, Prescott, Arizona, on the 4th day of June, 1963, at the hour of 10:00 o'clock A.M., why:

1. She should not pay up all delinquent accounts owed to the Upper Verde Ditch Company and the Lower Verde Ditch Company.
2. She should not be ordered to comply with the rules and regulations of the Upper Verde Ditch Company and the Lower Verde Ditch Company.
3. The water furnished to said defendant by the said ditch companies should not be discontinued until all accounts owed have been paid and all regulations complied with.

IT IS FURTHER ORDERED that a copy of the Petition filed in this action, along with this Order To Show Cause, be served upon the defendant.
