This matter having come for hearing on the Order to Show Cause in Re Contempt as to Respondents, A.L. HIETT and HAZELDELL HIETT, husband and wife, on June 18, 1990. Petitioners, GLEN W. EVERETT, VINCE V. HIGGINBOTHAM and HOWARD "DOC" FERGUSON, appearing in person and through counsel, L. Richard Mabery, and Respondents, A.L. HIETT and HAZELDELL HIETT, husband and wife, appearing through counsel, Richard Walraven. The court having been fully advised and finding that the Respondents, A.L. HIETT and HAZELDELL HIETT, husband and wife, are in violation of the court's Order dated February 6, 1989.

NOW, THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED:

1. That Respondents, A.L. HIETT and HAZELDELL HIETT, husband and wife, shall not restrict the Commissioners of the Verde Ditch, their employees or agents access to the Verde Ditch as it crosses HIETTS' property in Camp Verde, Arizona.


1                   2. That Respondents, A.L. HIETT and HAZELDELL HIETT,  
2 husband and wife, shall, within ten (10) days from June 18, 1990,  
3 deliver to the Petitioners the Soil Conservation plans and  
4 proposals for installing leak-proof headgates on the Verde Ditch  
5 to their property along with the other documentation and  
6 procedures previously ordered.

7                   3. That Respondents, A.L. HIETT and HAZELDELL HIETT,  
8 husband and wife, shall install the leak-proof headgates as  
9 approved by the Verde Ditch Commissioners within ten (10) days of  
10 June 18, 1990.

11                   4. That Petitioners are awarded the amount of \$616.00  
12 as and for sanctions to cover the costs incurred by the Verde  
13 Ditch Company for labor and equipment rental. Petitioners are  
14 further awarded attorney's fees in the amount of \$250.00 and  
15 \$50.00 as and for court costs.

16                   5. It is further ordered that in the event Respondents,  
17 A.L. HIETT and HAZELDELL HIETT, husband and wife, fail to comply  
18 with the February 6, 1989 order of the court or the orders of the  
19 court as set forth herein, the court shall impose a further  
20 sanction and penalty in the amount of \$100.00 per day for each  
21 and every day that the Respondents, A.L. HIETT and HAZELDELL  
22 HIETT, husband and wife, are in violation of this court's orders.
