

- A. Clinton Gray be appointed as a new Ditch Commissioner, at large, with his term to expire December 31, 2009;
- B. Vernon Hilbers be appointed as Chairman of the Verde Ditch Company for District 3 for a three (3) year term. Mr. Hilbers's term shall expire December 31, 2011;
- C. Albert Dupuy, Jr., be appointed as Ditch Commissioner for District 2, for the remainder of Commissioner John Reddell's term, which expires December 31, 2010;
- D. The prior appointments of Dugan McDonald, as Ditch Commissioner at large, with his term to expire December 31, 2009; and John Teague, as Ditch Commissioner for District 1, and with his term to expire December 31, 2009, be confirmed.
