Court's Order Promulgating New Rules and Regulations for the Operation of the Verde Ditch dated August 8, 1989, and recorded on October 17, 1989 at Book 2192, Page 24, Official Records of Yavapai County, and with Paragraph (4) of the Order for Authorization and Approval of a Special Assessment filed with the Court on September 27, 2005. Ms. Roberson has failed and refused to pay her regular and special Verde Ditch assessments. This Application is supported by the following Memorandum of Points and Authorities and the Affidavit of a Verde Ditch Commissioner, filed herewith and incorporated herein by reference.
