

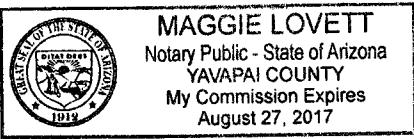

A Petition for Approval of a Memorandum of Understanding and Authority for the Verde Ditch Commissioners to Proceed has been filed with the Yavapai County Superior Court.
