ORDER 13.

I would like to apologize to the court for the confusion I caused on the First page documents I sent to the court on July 13th, 2015. I sent these first page documents to demonstrate to the court that the full context of these documents have been sent to all interested parties in this case. In my mistake, these particular documents were not sent to all of the interested parties in my initial submittal to the court.

I have since followed and complied with Rule 5(c), Arizona Rules of Civil Procedure on all of my court filings from day one starting on June 19th, 2015. All interested parties have all copies of all of my objections and pleadings.
