

31 The Court having considered the Petition (ex parte) filed by Verde Ditch Commissioners
32 Reed McManus, Jake McCune, Albert Dupuy, Jr., Cort Monroe and Craig Cooley requesting
33 approval for the Verde Commissioners to enter a construction contract for Ditch pipeline
34 improvements to the Verde Ditch; being fully advised in the premises and good cause appearing:

36 **THE COURT FINDS** that the Pipeline Agreement is appropriate and that the Verde Ditch
37 Pipeline Agreement is in the best interests of the Verde Ditch Company and its Shareholders.

1 **NOW THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED:**

- 2 1) The Petition Requesting Approval by the Verde Commissioners' actions to enter,
3 execute and effectuate the terms of the Pipeline Agreement on behalf of the Verde Ditch
4 Company is approved.

6 2) The Commissioners shall select not less than two Commissioners to execute any
7 documentation, contracts, completion or progress reports and authorize payment
8 requests on behalf of the Verde Ditch Company.

10 3) The Verde Ditch Commissioners are authorized to perform and undertake, on behalf of
11 the Verde Ditch Company, the Pipeline Agreement pursuant to the terms and conditions
12 set forth therein.

14 4) The Verde Ditch Company shall establish and maintain a separate account to document
15 deposits and disbursements of funds relating to the pipeline project and a complete
16 accounting shall be furnished and filed with the Court upon the completion of the
17 project.

19 5) The Verde Ditch Company shall file periodic status reports with the Court as the work
20 proceeds and upon the completion of the project.
