Anthony James Richards, by and through undersigned counsel, respectfully moves this Court to extend the Rule 12.9 deadline to file a Grand Jury Remand Motion for an additional thirty days. The trial court may extend the Rule 12.9 deadline when the motion is made within the time limits of Rule 12.9. *Maule v. Superior Court*, 142 Ariz. 512, 690 P.2d 813 (App. 1984).


It is not clear by the court record when, or if, the Grand Jury Transcript has been filed with the Court. On March 8, 2017, undersigned counsel received a copy of the transcript. On March 20, 2017 undersigned counsel received additional disclosure on the case which included approximately 420 photographs, several videos and maps, and an expert report. Counsel requires additional time to review the most recent disclosure to determine if there are any additional issues before filing a remand motion.

Undersigned counsel has spoken with Deputy County Attorney Kevin Schiff who has no objection to an extension.

Based on the foregoing, Defendant requests the Court to extend the deadline for filing a Rule 12.9 Remand Motion until May 1, 2017.
