IT IS ORDERED granting an extension of time to file the petition for review on or before May 1, 2024. No further extensions of time shall be granted absent extraordinary circumstances. This matter is subject to dismissal if the petition for review is not filed by May 1, 2024. (Tracie K. Lindeman Clerk)

Appellant's motion indicates that the Appellee State of Arizona does not object to the request.
Upon consideration,

IT IS ORDERED that Appellant's Motion for Procedural Order: Request to Extend the Time to File a Pro Per Petition for Review as to the Restitution Case Only is granted.

IT IS FURTHER ORDERED that Appellant may file a pro per petition for review as to 1 CA-CR 23-0083 on or before June 14, 2024. No further extensions of time will be granted absent extraordinary circumstances. Appellant's option to seek review from 1 CA-CR 23-0083 is subject to dismissal if Appellant's pro per petition for review is not filed by June 14, 2024.

IT IS FURTHER ORDERED that upon Appellant filing a pro per petition for review from 1 CA-CR 23-0083 the Clerk will open a new matter to file Appellant's pro per petition for review and file this order and Appellant's Motion for Procedural Order: Request to Extend the Time to File a Pro Per Petition for Review as to the Restitution Case Only in the new matter.
