8. 22-Aug-2023 WOULD AMEND RULES 44.1(e), 45(c), 78(g) AND 91.3 OF THE RULES OF FAMILY LAW PROCEDURE TO REQUIRE A FAMILY LAW COURT TO ISSUE AN "EDUCATION ORDER" WHEN ENTERING ANY FINAL ORDER INVOLVING DEPENDENT CHILDREN.
- ORDERED: Petition to Amend Rules 44.1(e), 45(c), 78(g) and 91.3, Arizona Rules of Family Law Procedure = ADOPTED as modified on an emergency basis, effective January 1, 2024.
- FURTHER ORDERED: The Court will decide whether to adopt the rule amendments on a permanent basis during its December 2023 Rules Agenda.
9. 24-Aug-2023 On January 4, 2023, Judge Bruce R. Cohen, Family Department Presiding Judge of the Superior Court in Maricopa County, filed a petition proposing to amend Rules 44.1(c), 45(c), 78(g), and 91.3, Rules of Family Law Procedure, to require a family law court to issue an "Education Order" when entering any final order involving children. The petition also proposed to adopt two new forms under Rule 97, Rules of Family Law Procedure. Comments were received, including one which recommended delaying consideration of this petition for further deliberations by a representative task force. The Court desires to implement this petition, with some revisions, during this rules cycle, but also wishes to consider public comment on it along with possible additional revisions. Upon consideration,
- IT IS ORDERED that, in accordance with Rule 28(h)(2), Rules of the Supreme Court, Rules 44.1(e), 45(c), 78(g), 91.3, and 97, Rules of Family Law Procedure, are amended on an emergency basis in accordance with Attachment A to this order, and Forms 19 and 20 to Rule 97, Rules of Family Law Procedure, are hereby adopted on an emergency basis in accordance with Attachment B to this order, effective January 1, 2024.
- IT IS FURTHER ORDERED that, pursuant to Rule 28(h)(2), Rules of the Supreme Court of Arizona, this matter shall be opened for public comment as to whether these amendments should be adopted permanently, with comments due no later than May 1, 2024, and any reply due no later than June 1, 2024. The Court will consider this issue at its August 2024 Rules Agenda. (Hon. Robert Brutinel)
