

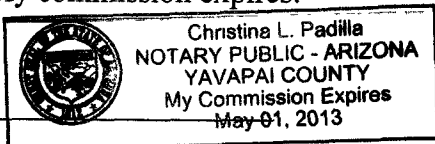
5 5. Pursuant to this Court's February 1, 2011 Ruling, the remaining property owners will
