
22 Defendant Robert D. Veres (hereinafter, "**Defendant**" or "**Veres**"), through his undersigned

24 Plaintffs' Rule 54(g) Motion for Award of Attorneys' Fees and Non-taxable Costs dated July 2, 2013
25 (hereafter, "**Rule 54 Motion.**") that was filed with the Court on July 22, 2013.

26 During the final transcription and edits to the Response, a footnote was inadvertently deleted.
27 On page 1, line 24, after the reference 'hereafter, Rule 54 Motion,' the following footnote should
28 have been cited and appended at the bottom of the page:

1 Plaintiff Varilek's Motion for Award of Attorneys' fees dated July 1, 2013, in the
2 "Cundiff v. Cox" litigation appears to be directed toward the Cox defendants, and not
3 Mr. Veres. The Varilek/Veres litigation (P1300-CV20090822) has been dismissed.
