1 NOW THEREFORE IT IS ORDERED that Earl Hopper, Marion E.  
2 Davidson and H. C. Gambe , be and they are hereby appointed water  
3 commissioners under the decree entered herein on March 23, 1909,  
4 to administer the affairs of said Woods or Verde Ditch, and they  
5 are authorized and empowered to enforce the provisions of said  
6 judgment and decree with reference to the payment of assessments  
7 for the maintenance and upkeep of said ditch, headgate and  
8 appurtenances, and

9 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the said  
10 Earl Hopper, Marion E. Davidson and H. C. Gambe , be and they are  
11 hereby authorized and empowered to carry out the terms and con-  
12 ditions of said judgment and decree with reference to the  
13 appropriate uses of the waters of said Woods or Verde Ditch, as  
14 provided in said decree.
