

The Verde Ditch Company has repeatedly been denied access along the Verde Ditch as it concerns the Hood Allotment and such actions are believed to be approved by or under the jurisdiction of the Bureau of Indian Affairs. Repeated attempts have been made to resolve this controversy by the Verde Ditch without success.

The Verde Ditch Company further requests that the Court enter such further orders as needed and necessary in order to properly maintain the ditch over and across the **Bureau of Indian Affairs, United States Department of the Interior.**
