

15 COMES NOW Mr. Mitchell, by and through undersigned defense counsel, and respectfully
16 requests that the Pre-Trial Conference/Possible Change of Plea hearing set for Friday (this Friday)
17 July 30, 2021 at 8:30 a.m. be continued to September 10, 2021. This request is without objection
18 from the State's Prosecutor, Casi Harris, and is with a waiver of time to reach the new date. The
19 parties continue to work together toward a non-trial resolution in this matter, and have another
20 meeting scheduled on August 4. Therefore, as negotiations are still underway, and will not be
21 complete by this Friday, the requested continuance is made to allow more time to conclude
22 negotiations and to have a meaningful hearing on September 10, 2021.

26 Defense. Of note, Defense counsel is unavailable on September 3 as he is in trial in Mayer Justice
