Right to a Lawyer

which is a felony under the laws of the State of Arizona, and that if I am found guilty, I can be given a severe punishment, including imprisonment in the Arizona State Prison, incarceration in the Yavapai County Jail, by a fine or other penalty.

I understand that, under the Constitution of the United States, and of the State of Arizona, I have the right to be represented by a lawyer at all critical stages of this criminal case-before trial, at the trial itself and during proceedings to determine what sentence should be imposed if I am found guilty. I understand that if I am unable to obtain the services of a lawyer without incurring substantial hardship to myself or to my family, one will be furnished for me free of charge.

I understand that the services of a lawyer can be of great value in determining whether the charge against me is sufficient as a matter of law, whether the procedures used in investigating the charge and obtaining evidence against me, including any confession I may have made, were lawful, whether an act I may have committed actually amounts to the crime of which I am charged, whether I have any other valid defense to the charge, and, if I am found guilty, whether I should be placed on probation, be required to pay a fine or be sentenced to a term of imprisonment. I understand that if I am found guilty of the offense charged, the Court may sentence me to a term of imprisonment even though I have given up my right to a lawyer.

Right to a Lawyer at Any Time

I understand that I can change my mind about having a lawyer at any time by asking the Judge to appoint a lawyer for me, but that I will not be entitled to repeat any part of the case already held without a lawyer.

Certification and Waiver

After reading and understanding all of the above, I hereby give up my rights to a lawyer in this case and to have a lawyer furnished for me free of charge if I cannot afford one.
